

WORLD ARCHERY CONSTITUTION AND RULES

BYLAW

Approved by World Archery Executive Board on 30 June 2013
Effective as of 1 July 2013

Book 4, Article 26.4.1.1

26.4.1.1

Time limit Qualification rounds : one and a half minute is the time limit for athletes in all divisions to shoot two arrows in. As soon as the group in front has cleared the shooting peg the next group moves from the waiting area to the area with the picture of the animal target to be shot. When the group in front has cleared the target and is assumed to be at safe distance, the group may go forward from the picture-area to the shooting peg (see Article 23.2.) and the first athlete in the group starts shooting. Due to safety reasons and the time-limit, the arrow can only be nocked at the shooting peg.

Time limit Elimination and final Rounds: One minute is the time limit for athletes in all Divisions to shoot one arrow.

Book 4, Article 26.4.1.2









26.4.1.2

The appropriate time limit as stated in 26.4.1.1 of one and a half minute for each athlete in the group begins, when they arrive at the peg.

WORLD ARCHERY CONSTITUTION AND RULES

Book 4, Article 22.4

An interpretation was raised by Slovak Archery Association on whether the Tradetech Galaxy Riser is legal in the 3D and Field Instinctive Bow Division.

The Constitution and Rules Committee (“C&R”) finds the question presented to be within the terms of reference of the Technical Committee.

C&R has determined that the following interpretation is not contrary to the existing rules or Congress decisions.

Response from the Technical Committee:

It is the unanimous opinion of the Technical Committee, after consultation with the Field Committee, that the riser presented for interpretation is not legal for use in the instinctive bow division of World Archery. The riser is adjustable in weight and presents a clear violation of the rules.

 - Národnej antidopingovej agentúry
- Zákon o športe --- Zákon č. 440/2015 Z.z.
- Zoznam zakázaných látok a metód

Poznámky k štúdiu pravidiel

- Je potrebné pochopiť zmysel (dôvod) pravidla
- shall
 - Expressing an instruction, command, or obligation.
 - ‘every employer shall take all practicable steps to ensure the safety of employees’
- Don't just open the book to see if you can find a penalty to take away an archer's score, look in the book to find a rule, if possible, to save the athlete's score.
- If the athlete has broken a rule that could give him an advantage over the other competitors, distance, time, number of arrows, score, then you must take firm and immediate punitive action. You must do so to protect the rights of the other athletes who did not break the rule.
